• ne of the most rewarding activities for me at the cooperative is visiting with and recognizing members who are serving our community with distinction. Presenting the Good Samaritan Award from our regional association to Ben and Jenna Marchi of St. Michaels was joyful.

Bestowed by the Virginia, Maryland & Delaware Association of Electric Cooperatives, the purpose of the Good Samaritan Award is to honor individuals who provide exceptional service to others, either within their chosen profession or as a passion beyond. Their service constitutes a body of good works so extraordinary, so selfless and so lifechanging that it is worthy of being held up to others as a "gold standard" example of philanthropic community service.

The annual meeting and dinner will be held at the Fountains Wedding & Conference Center at 1800 Sweetbay Drive in Salisbury, Maryland. Doors will open at 4:30 p.m. for members to register, visit with staff and vendors, and enjoy dinner.

The business portion of the annual meeting will begin at 6 p.m. with President and CEO Mike Malandro reporting on the Co-op business over the last 12-months. Three Board members will be standing for reelection during the 2025 meeting. submitted, reviewed and approved by the Credentials and Elections Committee. Because there is only one approved director candidate for each district, the Committee has invoked bylaws section 4.06(b). This section states that in the event of an uncontested election, Choptank Electric Cooperative may forego the balloting process. A final vote to elect directors will occur during the annual meeting. This saves the Cooperative and its members thousands of dollars in the printing and mailing of ballots and the hiring of a voting service provider.

In addition to the formal business of the meeting, there will be an opportunity for students to receive scholarships. Ten \$1,000 Luck of the Draw scholarships will be awarded to students who pre-file their applications and are present at the meeting with their parent or legal guardian who is an active Choptank member. Applications, qualifications and other details about the scholarships are posted on the website under Member Benefits and are covered on page 16 of this *Cooperative Living* magazine.

All members who attend the annual meeting will be awarded a \$10 bill credit on their next electric bill (limited to 1 per membership). There will also be door prizes drawn at the end of the meeting ranging from \$100-\$500 in bill credits.

## Choptank Fiber Celebrates Rural Connection Milestones

hoptank Fiber connected 5,000 customers this February with reliable and affordable high-speed internet on the Eastern Shore. With over 1,250 miles of distribution fiber laid, service is now available to 12,000 locations. Since its first connection in 2021, Choptank Fiber has remained ahead of schedule in every aspect of its fiber construction and buildout process.

"We are, of course, proud of these accomplishments, but more importantly we are celebrating that Choptank Fiber has stuck to its mission of serving our unserved rural electric cooperative members and reinvesting profits back into infrastructure development," shared Mike Malandro, President of Choptank Fiber and CEO of Choptank Electric Cooperative.

Using the cooperative principles that are at the core of its business, Choptank Electric Cooperative created Choptank Fiber to deliver reliable and affordable internet service to families and businesses throughout its service territory where current providers wouldn't build. "This is a prime example of putting members first by utilizing our existing infrastructure and working with local government and community members to deliver this much-needed service," added Malandro. Following a successful vote in 2020 by Choptank Electric Cooperative members to become member-regulated, the broadband subsidiary was formed. After years of expressing to the Cooperative a need for reliable and affordable internet, rural residents are finally able to join the digital landscape at home and in their businesses.

Taylor Hall had Choptank Fiber installed at his house outside of Preston this January after struggling to find reliable internet for 17 years. "As primarily a teleworker, I've been astonished at the difference Choptank Fiber speeds make in my daily work," shared Hall. "I'm able to get into remote tools which require a good connection that I wasn't always able to reach with previous Wi-Fi providers. Online meetings are better, and my wife can access the internet and stream movies without having to schedule around my job."

Theo Hobbs and his family have been Choptank Fiber customers for nearly a year now. "I can work from my home office without being concerned about the wireless signal or loss of bandwidth," said Hobbs. As Senior Pastors of Lighthouse Church of God in Berlin, he and his wife, Linda, took advantage of the business packages as well. "Our service at the church handles all our security camera bandwidth needs easily. Customer service has been very accessible and quick to respond."

Tim McGaha, VP of Operations for Choptank Fiber, remarks on the world-class service being constructed with the future in mind. "Our fiber infrastructure and speeds will support our customers" needs as technology continues to advance many years down the road. We are building the network of tomorrow, today."

Cecil County's Broadband and GIS Manager, David Black, has worked closely with Choptank Fiber for the past few years to connect over 500 unserved locations to highspeed internet. "Choptank Fiber is extremely responsive to meeting the needs of Cecil County's unserved residents and businesses," expressed Black. "These locations were originally unserved for a reason; they are extremely isolated, challenging to reach and require significantly more effort to connect. Choptank Fiber's staff have the technical acumen necessary to solve the most challenging broadband builds. Our collaboration is a true

partnership, and Choptank Fiber's dedication to serving its customers is top notch."

Residential service offerings started four years ago with broadband packages and have since expanded to include the complimentary CommandIQ mobile app for wholethan ever; to keep you connected to what matters most, now and for generations to come," concluded Malandro.

Commercial broadband packages are now available with added services, including cloud-based business phone lines, SmartBiz (a business managed Wi-Fi service) and the CommandWorx mobile app.

As Choptank Fiber looks to the future, it will continue to serve as the hub for technology on the Eastern Shore by providing rural businesses and consumers with the services and education they need. "Our commitment remains stronger

## Member-owned Home Instead Provides Valuable Option for Many Seniors

estled into a business park on the outskirts of Easton is a gem with dedicated staff providing services to thousands of seniors across five counties on the mid-shore. Home Instead offers aging adults the opportunity to stay in the homes they love while contracting for various levels of support services.

Ben and Jenna Marchi, Choptank Electric Cooperative members from St. Michaels, own the franchise and employ more than 150 caregivers, offering services for Alzheimer's and dementia support, and personal, hospice and chronic illness care.

"We feel truly blessed to be able to make a living this way," said Ben as he discussed their dedication to identifying and training staff to assist seniors in our rural community. Experts expect a growing number of aging adults will need support services in the years ahead.

Some of the Home Instead care professionals are contracted to help clean a home, shop for groceries and provide nutritious meals. Others provide transportation to doctors' appointments, worship services, fitness classes and more. Regular companionship to talk, garden or play cards is also a need for many aging adults and can be organized through Home Instead.

Members of the Choptank Board of Directors visited the Easton location with our President & CEO, Mike Malandro, to learn more about the operation and to honor Ben and Jenna Marchi with the 2024 Good Samaritan Award. While the business is one of 635 similar franchise operations across the United States, Ben and Jenna consider it a family business. Ben's parents own a franchise in Bozeman, MT and Jenna's parents recently retired and sold their operation in Bel Air, MD.

"We love being cooperative members," explained Ben. "We recognize the importance of investment and concern for our community—a key Cooperative principle."
