

## **Dear Members,**

As you continue to relax and enjoy summer activities on the Eastern Shore, I want to give you some good news about your electric bill. Old Dominion Electric Cooperative (ODEC), Choptank Electric Cooperative's wholesale power provider, has experienced lower costs for generating and purchasing power over the past several months. These lower costs are largely the result of less expensive fuel used to generate electricity and lower power prices across our region. ODEC is a not-for-profit electric cooperative just like Choptank, and its mission is to provide us with the most reliable power at the lowest possible cost while meeting our state and national environmental goals.

ODEC and its board of directors have lowered the cost of wholesale power by \$1.50 per megawatt-hour, which allows Choptank to pass the savings on to you, our memberowners. You will see the reduced rates on your electric bill beginning August 1st.

These savings will amount to \$1.50-\$2.00 off the average household's monthly bill — that's \$1.50 per 1,000 kwh, which is the average monthly residential use. This change will be reflected in the Power Cost Adjustment line under the Supplier Charges side of your bill.

At a time when many costs have risen from gas to groceries, your cooperative lowers costs to member-owners wherever possible. I hope you will continue to enjoy your summer and will relax just a little more knowing your electric cooperative has your back.

noptank Electric Cooperative sponsored five local high school students this summer to attend Youth Tour in Washington, D.C.

The Electric Cooperative Youth Tour has brought high school students to our nation's capital for a week in June annually since the late 1950s. This year over 2,000 participants from 44 states joined together to trade state pins and learn about the important roles electric cooperatives play in their communities.

Choptank's students gained personal understanding of their roles as citizens by meeting with Rep. Andy Harris, Sen. Chris Van Hollen, staff from Sen. Ben Cardin's office, and Gov. Wes Moore. They traveled with other cooperative


students affiliated with the Virginia, Maryland & Delaware Association of **Electric Cooperatives** visiting monuments and museums, a dinner cruise on

the Potomac River, a Washington Nationals baseball game and Arlington National Cemetery. A total of 1,500 students all came together for Youth Day, where they met each other in a fun pep-rally format and heard featured speakers.

"It's important for students to learn about the political process and interact with their elected officials," said Mike Malandro, President and CEO of Choptank Electric Cooperative. "After Youth Tour, these individuals become more engaged community members and have memories and friendships that last a lifetime."



# AND BEAT THE PEAK

s summer months roll in, we find ourselves cranking the thermostat down to adjust to the outside temperatures. In doing so, it is Choptank Electric Co-op's job to supply a reliable flow of electricity to keep members cool and connected.

During the extreme summer temperatures, we spend more time inside trying to stay cool by bumping the thermostat down to cool off. This increased use of electricity will cause spikes in demand, also known as energy peaks. During peak times, Choptank Electric works closely with Old Dominion Electric Cooperative, our wholesale power provider, to

ensure that a steady supply of electricity is always available to meet our community's energy needs.

When the demand for electricity is higher than usual, power providers must speed up electricity production. In these cases, electric utilities will pay more for electricity produced during the peak. This general increase in electricity use is why you typically see higher bills during the hottest months.

Choptank Electric Cooperative's Beat the Peak is a voluntary program where members are encouraged to conserve or limit energy use during peak times. Peak times are hours of

the day that incur the highest energy use, typically in the morning as people start their day and in the evening as people return to their homes. With this voluntary program, members will be notified via email when to turn back their thermostat setting.

This can also go toward reducing the use of appliances and unnecessary lights. The message will provide you with the anticipated day and time of the peak period to remind you of the importance of cutting back on energy consumption. Reducing the peak impacts the power-supply cost to every co-op member. Together we can make a difference conserving energy, one member at a time.

### Dear Choptank,

We experienced a power outage at approximately 4:15 a.m., Sunday, May 26th. About 45 minutes later we received a phone call from one of your employees to verify that we had no power. He then advised that only our residence was affected and that someone would arrive shortly to correct the problem. A service technician arrived at approximately 6:15 a.m.

He quickly diagnosed the problem as a fused underground line between the transformer and our house. Additional technicians and equipment arrived to assist in the location process. The line fusion was located under a large pine tree. A small backhoe and several men dug a trench, found and repaired the line and re-routed it around the tree. Soils were then re-graded properly.

We write to sincerely thank you for the manner and timeliness in which your organization responded. All your technicians were obviously well trained. We were also thankful that everyone was all so polite, informative, knowledgeable and very efficient. You should be proud of each and every staff member that assisted us in our time of need.
