Choptank Electric Seeks Your Input

On Energy Policy Standards

n November 15, 2021, the Infrastructure Investment and Jobs Act was signed into law. Among other things, the Act established two new federal standards under the Public Utility Regulatory Policies Act (PURPA) Section 111(d). Section 111(d) requires covered electric utilities to consider the new standards and make a determination concerning whether or not it is appropriate to implement each standard. The full text of the law can be found online at https://www.law.cornell.edu/uscode/ text/16/chapter-46 or a copy may be

requested from the Cooperative by calling 1-877-892-0001 and asking for the Legal Department.

Pursuant to the law, this serves as official public notice of Cooperative members' opportunity to comment on the standards and/or attend the hearing. If you wish to provide input, please send your comments in writing by January 15, 2023, to Choptank Electric Cooperative, Attn: General Counsel, P.O. Box 430. Denton, MD 21629.

A brief description of each standard is listed below. This is for informational

purposes only and is not meant to replace the full text of the law. The Cooperative's Board of Directors will conduct a hearing on October 18, 2023, at 5PM at its Denton District office located at 24820 Meeting House Road, Denton, MD 21629. At the hearing, Choptank's staff will introduce its report, all written comments will be considered, and members attending in person will have an opportunity to be heard. At the conclusion of the hearing, the Cooperative's Board will determine whether to implement the new standards. This determination will then be available to the public on the Cooperative's website.

SECTION 2621 PURPA 111(D) STANDARDS

20. Demand-Response Practices

(A) In general. Each electric utility shall promote the use of demand-response and demand flexibility practices by commercial, residential, and industrial consumers to reduce electricity consumption during periods of unusually high demand.

(B) Rate recovery. A nonregulated electric utility may establish rate mechanisms for the timely recovery of the costs of promoting demand-response and demand flexibility practices in accordance with subparagraph (A).

Current Co-op Activities: For certain rate classes, Choptank currently offers time-of-use rates and an opportunity to receive a monetary credit for load reduction during peak hours. More information can be found under our Terms & Conditions located at https://choptankelectric.coop/rates.

21. Electric Vehicle Charging Programs

Each State shall consider measures to promote greater electrification of the transportation sector, including the establishment of rates that:


- (A) promote affordable and equitable electric vehicle charging options for residential, commercial, and public electric vehicle charging infrastructure;
- (B) improve the customer experience associated with electric vehicle charging, including by reducing charging times for light-, medium-, and heavy-duty vehicles;
- (C) accelerate third-party investment in electric vehicle charging for light-, medium-, and heavy-duty vehicles; and
- (D) appropriately recover the marginal costs of delivering electricity to electric vehicles and electric vehicle charging infrastructure.

Current Co-op Activities: Choptank currently owns two public EV chargers: one in St. Michaels and one at the Harriet Tubman Museum in Dorchester County.



OPEN MEMBERSHIP

Membership in a cooperative is open to all people who can reasonably use its services and stand willing to accept the responsibilities of membership, regardless of race, religion, gender or economic circumstances.



AUTONOMY AND INDEPENDENCE

Cooperatives are autonomous, self-help organizations controlled by their members. If they enter into agreements with other organizations, including governments, or raise capital from external sources, they do so on terms that ensure democratic control as well as their unique identity.



CONCERN FOR COMMUNITY

Cooperatives work for the sustainable development of their communities through policies supported by the membership.



DEMOCRATIC MEMBER CONTROL

Cooperatives are democratic organizations controlled by their members, who actively participate in setting policies and making decisions. Representatives are elected among members and are accountable to them. In primary cooperatives, members have equal voting rights (one member, one vote); cooperatives at other levels are organized in a democratic manner.



EDUCATION, TRAINING AND INFORMATION

Education and training for members, elected representatives (directors/trustees), CEOs and employees help them effectively contribute to the development of their cooperatives. Communications about the nature and benefits of cooperatives, particularly with the general public and opinion leaders, help boost cooperative understanding.

MEMBERS' ECONOMIC PARTICIPATION

Members contribute equitably to, and democratically control, the capital of their cooperative. At least part of that capital remains the common property of the cooperative. Members allocate surpluses for any or all of the following purposes: developing the cooperative; setting up reserves; benefiting members in proportion to their transactions with the cooperative; and supporting other activities approved by the membership.



COOPERATION AMONG COOPERATIVES

By working together through local, national, regional and international structures, cooperatives improve services, bolster local economies and deal more effectively with social and community needs.

Preventative Maintenance is Key

hen it comes to reliability, preventative maintenance is key. It plays a very important role in the upkeep of our power grid. A solid preventative maintenance strategy is important for any large infrastructure or system. Take, for instance, the original bay bridge. The east bound span began construction in 1949, 73 years ago. I'm willing to bet the majority of us have sat in traffic on that bridge because of up-dates and maintenance. I'm also sure that none of us praised preventative maintenance while in traffic. There was no one saying 'I sure am happy about this preventative

maintenance!' Traffic is no fun, but it is a small price to pay considering what the bridge means to us.

Our operations team and lineworkers routinely perform preventative maintenance throughout the year. The photos that you see are from a particular job they did in the heat of July. This crew's focus that morning was in south Dorchester County where they cleared rights-a-way, replaced 2 rotting poles, installed a switch and pulled tight some low spans of wire. All in the context of land where bucket trucks could not reach. Curtis Short, our Manager Regional Operations had this to

say, "Keeping our members' lights on is a top priority. A proactive maintenance program has proven to be the most effective approach. We constantly patrol our lines and test our equipment looking for potential problems, making repairs as needed."

We are never happy to tell our members about a planned outage at their home. Our members do a great job of playing a very important role as member owners. Reliably paying their bills, keeping updated on our co-op and we very much appreciate the thank you notes we receive. However, our members are the very reason we make

those phone calls as proactive maintenance can detect problems in advance, minimizing emergencies and improve equipment longevity. All of this reduces maintenance costs and, in turn, saves our members money and keeps them from unwanted extended outages.

Planned outages are a necessary part of bringing our members reliable and affordable electricity. We have 6,345 miles of line within our cooperative. With enough line to criss cross America two plus times, there is a lot of room for error. Poles end up rotting, equipment does have a lifespan and trees do end up falling. Our preventative maintenance program puts us ahead of the curve. We clear



rights-of-way, trim trees back, replace equipment and much more in the effort of keeping our infrastructure as strong as possible and the lights on. Keeping that in mind, we are proud to say that our reliability rating is 99.98%.



already earned their Credentialed
Cooperative Director (CCD) and
Board Leadership Certificate (BLC)
through NRECA and who wish to
continue to learn throughout their
service on the board. We are proud
to say that our Board Member Bob
Arnold, representing Queen Anne's
County, has achieved that status.

"The Director Gold certificate is geared toward directors who are committed to continuing their education beyond CCD and BLC and who desire a tangible credential that reinforces their stature as part of an experienced and educated group of directors," says Jeff Rathell, Board Chair. "Director Gold also demonstrates to co-op members a director's ongoing commitment to advancing their knowledge and performing their fiduciary duty to the best of their ability," Rathell said.

For a director to earn the Director Gold certificate, they must have already earned the CCD and BLC and earn three additional credits from the BLC series of courses. Unlike the CCD and BLC certificates, Director Gold includes a continuing education requirement which calls for directors to earn three credits of approved course work and/ or conferences every two years to maintain their Director Gold status.


