# Three Things You Probably Didn't Know About Generator Safety

If you own a generator, chances are you could be at risk of electrocution, fire injury, property damage, or carbon monoxide poisoning if you do not follow the necessary safety rules. When the power goes out, make sure you know these guidelines before using your generator:

- Never connect a generator directly to your home's wiring unless your home has been wired for generator use. This can cause backfeeding along power lines and electrocute anyone coming in contact with them, including lineworkers making repairs. Have a licensed electrician install the equipment necessary to safely connect emergency generators to your home.
- ✓ Always plug appliances directly into generators. Connecting the generator to your home's circuits or wiring must be done by a qualified, licensed electrician who will install a transfer switch to prevent backfeeding.
- Use heavy-duty, outdoor-rated extension cords. Make sure extension cords are free of cuts or tears and the plug has three prongs. Overloaded cords can cause fires or equipment damage.

#### Want even more generator safety tips? Keep reading:

Ш	Ensure your generator is properly grounded.
	Never overload a generator. A portable generator should only be used
	when necessary to power essential equipment or appliances.
	Turn off all equipment powered by the generator before shutting it down.
	Keep the generator dry. Operate it on a dry surface under an open
	structure.
	Always have a fully charged fire extinguisher nearby.
	Never fuel a generator while it is operating.
	Read and adhere to the manufacturer's instructions for safe operation.
	Never cut corners when it comes to safety.

We encourage you to protect the well-being and safety of your family during outages, and safeguard those who come to your aid during emergency situations. When we work together for safety and the good of our communities, we all benefit.

## **3-Step** HVAC Test

As summer temperatures rise, so do electric bills. Follow these steps to test the efficiency of your HVAC unit.

The outdoor temperature should be above 80 degrees, and you should set your thermostat well below the room temperature to ensure the system runs long enough for this test.

- Using a digital probe thermometer (about \$12), measure the temperature of the air being pulled into your HVAC filter.
- Measure the temperature of the air blowing out of your A/C vent.
- 3. Subtract the A/C vent temperature from the HVAC filter temperature. You should see a difference of about 17 to 20 degrees. If the difference is less than 17 degrees, you may need a licensed technician to check the coolant. If the difference is greater than 20 degrees, your ductwork may need to be inspected for airflow restrictions.

### **2018 Capital Credit Allocation**

Choptank Electric Cooperative is a non-profit member-owned utility. Any margins (profits) above the cost of service are allocated back to our member/owners based on how much electricity each member purchased during the year.

The 2018 capital credit allocation was processed in June 2019, after the 2018 financial statements were reviewed and audited. The 2018 capital credit allocation notice for active members will be shown on the July 2019 electric bill in the left message area above the bill stub. Inactive members with 2018 electricity billings will be mailed a separate allocation notice.

The capital credits (margins) allocated to members' accounts for 2018 totals \$13,286,307. This is allocated between Choptank Electric Cooperative, which

totals \$12,021,677 and Old Dominion Electric Cooperative (ODEC), Choptank's energy supplier, which totals \$1,264,630.

The Choptank Electric Board of Directors reviews the Co-op portion of capital credits each year and decides how and when to repay the amounts allocated. Their decision is based on a variety of factors including the overall financial condition of the Cooperative. Any decision to repay the ODEC portion of capital credits would be entirely contingent upon refunds received from Choptank's energy supplier.
