DORCHESTER COUNTY

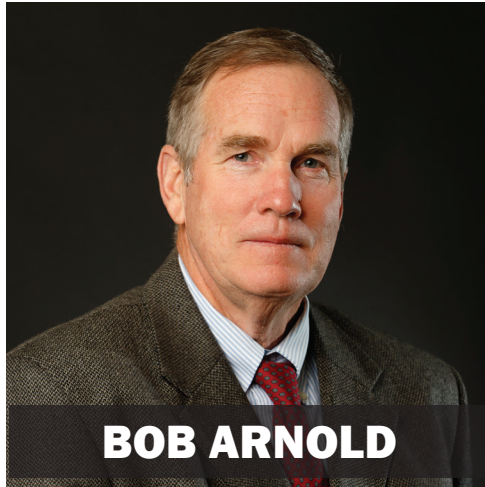
