Their petitions have been approved by the Credentials and Elections Committee. Because there is only one approved Director candidate for each district, the Committee has invoked Bylaws section 4.06(b). This section states that in the event of an uncontested election, Choptank Electric

may forego the balloting process. This saves the Cooperative and its members thousands of dollars in printing and mailing the ballots, along with the costs of other voting services.

The business meeting will begin with President and CEO Mike Malandro reporting on Co-op business during 2021. At the meeting's conclusion, the Luck of the Draw scholarships and door prizes will be awarded. The door prizes this year will be a variety of bill credits ranging from \$100 - \$500.

Luck of the Draw Scholarships Awarded at Annual Meeting

The Luck of the Draw Scholarship is awarded by randomly selecting students from a live drawing at the end of our Annual Meeting. To enter the drawing, students must fill out a basic information application, read a Co-op article, and answer a ten-question quiz based off the Co-op article.

This year, the Annual Meeting will be held on Thursday, April 28, 2022, at the Wicomico Youth and Civic Center. The Board of Directors will award ten \$1,000 scholarships to students who meet the following qualifications:

- Be enrolled or planning to enroll at an accredited two- or four-year college, university, or a technical school for the 2022 fall term;
- Winners of prior years, employees, and immediate family members of Choptank Electric are not eligible to participate.





Choptank Fiber Connects Members on the Lower Shore



Ribbon cuttings for broadband connections were held in Worcester and Somerset Counties.

Choptank Fiber successfully installed gigabit-speed internet service in rural Worcester and Somerset Counties for the first time. To celebrate this milestone, we invited the community and elected officials for ribbon-cutting ceremonies held at Chesapeake Bay Dairy (Worcester County) and Hawks Corner (Somerset County).

Laura Holland, owner of Chesapeake Bay Dairy, said she was thrilled. “Since they connected our service, the kids haven’t stopped us-

ing it. I’ve been telling our neighbors how fast everything is when you get online, there is no waiting or spinning, items come up instantly.”

Mike Malandro, President and CEO, thanked members and staff of the Worcester County Commission. “This project is the start of internet connection for many unserved households on the lower Shore,” he explained. “Working together, we look forward to giving rural families and businesses, like the Hollands’ Dairy, access to reliable internet so their operation can

continue to develop here in Worcester County.”

Somerset County Commissioner President and Choptank Director Craig Mathies had this to say about the new fiber connection. “Broadband is vital to economic development and building our communities here in Somerset County... This will open up so many opportunities for our residents; this is what we need, and I want to thank all of you for your hard work.”

When Winter Storm Frida brought a blanket of ice and snow to the Eastern Shore on Monday, Jan. 3, Choptank Electric Cooperative was ready to serve its members immediately.

The outages were mostly concentrated in Talbot, Dorchester, Wicomico, and Caroline Counties with over 1,600 members without power

during the height of the storm. Throughout the course of the storm, there was a total of 2,571 members without power, but all members were restored before the day’s end.

After the storm ended, in an effort to assist other restoration efforts in our region, 10 linemen and two supervisors were sent to Rappahannock Electric Cooperative on

Wednesday, Jan. 5, to help restore power to 30,000 members.

Ten days later, they finally returned home on Thursday, January 13, after grueling 18-hour shifts. REC’s outages consisted mostly of downed power lines and poles caused by ice and trees, which takes time to rebuild, especially in the remote parts of their territory.

Choptank Electric Tariff Changes for the Irrigation Rate

As a Member - Regulated Cooperative, Choptank Electric's Board of Directors has the authority to establish and change rates created by the Cooperative. Here are a couple of recent changes for you to be aware of:

General Service-Irrigation (FI): effective with billings rendered on or after March 1, 2022

This is a revision of the current irrigation tariff. Demand charges no longer fluctuate based on the season, and a horsepower charge no longer applies. Each month,

when 500 kWh or less is consumed under this rate, only an energy (kWh) charge will apply. Both energy (kWh) and demand (kW) will be billed when consumption exceeds 500 kWh. Additionally, the applicability of the rate has been expanded.

Load Control Rider-Irrigation (LC-FI): effective with billings rendered on or after March 1, 2022

This is a voluntary rider that may be paired only with the General Service-Irrigation (FI) rate. Under this rider, members who curtail load

during specific peak periods are eligible for a curtailment credit.
